CIRCULAR

Subject: Filling up of the vacant posts in the Central Administrative Tribunal on deputation basis.

It is proposed to fill up the following posts in the Central Administrative Tribunal on transfer on deputation basis for a period of one year likely to be extended or curtailed in administrative exigencies. The Pay and allowances and other terms of deputation of the officers/officials selected for the said posts will be regulated in accordance with the instructions contained in the Department of Personnel & Training OM No.6/8/2009-Estt.(Pay-II) dated 17/06/2010. The employees of Central Administrative Tribunal are eligible for and may continue to retain General Pool Residential Accommodation as per extant rules. The name and number of posts, classification, place of posting, tenure, scale of pay and eligibility criteria for filling up of these posts on deputation basis are as under:-

I DEPUTY CONTROLLER OF ACCOUNTS (01 Post)

Group 'A' (Gazetted) in PB-3 in the scale of pay of Rs. 15600-39100/- plus Grade Pay Rs. 6600/- at the Principal Bench (New Delhi) of the Tribunal on deputation basis initially for a period of one year.

Eligibility Criteria:-

- (i) Officers holding –
 - (a) analogous post in the Central Departmentalized Accounting Organisation of the Controller General of Accounts with a minimum 2 yrs. of service in the grade of DCA under C.G.A., C.G.D.A., P & T Accounts or Railway Accounts Service.
 - (b) The Accounts Officers with a minimum of 10 yrs. service in the grade of Accounts Officer in the C.G.A., C.G.D.A. and P & T Accounts.

II PRINCIPAL PRIVATE SECRETARY (02 posts 01 Post Reserved for ST) :-

Group 'A' (Gazetted) in the scale of pay of Rs.10000-325-15200 (Revised Pay Band-3 Rs.15600-39100 Plus Grade Pay Rs.6600/-). Selected Officer may be posted in the Bench where the vacancy would be available at that relevant point of time. Vacancies in the grade presently available at Principal Bench (New Delhi) and Bombay Bench of the Tribunal.

Eligibility Criteria:-

- (i) Officers holding-
 - (a) Analogous posts in the Central Government/State Government/High Courts with atleast two years regular service in the grade of Principal Private Secretary in PB-3 Rs. 15600-39100/- plus grade Pay Rs. 6600/-.
 - (b) Private Secretary with atleast eight years regular service in PB-2 Rs. 9300-34800/- with Grade Pay Rs. 4800/- and PB-3 with Grade Pay Rs. 5400/-.

III COURT OFFICERS/SECTION OFFICERS (12 posts) :-

Group 'B' (Gazetted) in the scale of pay of Rs. 6500-200-10500 (Revised Pay Band-2, Rs.9300-34800 Plus Grade Pay Rs.4800/-) at the Ahmedabad, Bombay, Guwahati, Hyderabad, Jodhpur, Lucknow and Patna Bench of the Tribunal or in any other Bench of CAT on transfer on deputation basis initially for a period of one year.

Eligibility Criteria:-

Essential:

- 1. Persons working under the Central Government/State Governments/High Courts/Subordinate Courts;
 - a) (i) Holding analogous post on regular basis; OR
 - b) (ii) Holding posts of Assistant or equivalent in the pre-revised scale of pay of Rs.5500-9000 with 8 years regular service and
 - b) Possessing the Degree of a recognized University or equivalent

Desirable: Degree in Law

IV PRIVATE SECRETARY(14 posts) :- Group 'B' (Gazetted) in the scale of pay of Rs.6500-200-10500 (Revised Pay Band-2, Rs.9300-34800 Plus Grade Pay Rs.4800/-) at Allahabad, Ahmedabad, Calcutta, Jaipur, Jodhpur, Jabalpur and Patna Bench of the Tribunal on transfer on deputation basis initially for a period of one year.

Eligibility Criteria:-

- (i) Private Secretaries with two years of regular service in the grade of Rs.6500-200-10500 (Pre-revised) in Central Government/State Government/High Courts;
- (ii) Court Master/Stenographer Grade 'C' with at least eight years regular service in the grade of Rs.5500-175-9000 (pre-revised) or persons holding analogous post in the grade of Rs.5500-175-9000 (pre-revised) with at least 8 years regular service and possessing a speed of 120 w.p.m. in shorthand and 40 w.p.m. in typewriting (English) in Central Government/State Government/High Courts.

- V **ACCOUNTS OFFICER (06 posts) :-** Group 'B' (Gazetted) post in the scale of pay of Rs.7450-225-11500/- (Revised PB-2, 9300-34800 plus Grade Pay Rs.4600/-) one each at Madras, Patna, Calcutta, Bangalore, Ernakulam and Jodhpur Benches on transfer on deputation basis initially for a period of one year.

Eligibility Criteria:-

- (i) Regular Accounts/Audit Officers from any of the Organized Accounts Department.
- (ii) Officers under the Central Government holding an analogous post on regular basis who have undergone training in Cash and Accounts work in ISTM or equivalent and possess experience in Cash & Accounts & Budget work.

OR

- (iii) Junior Accounts Officer/Accounts Audit Officers or equivalent in the scale of Rs.5500-9000/6500-10500 (Pre-revised)/Rs.9300-34800 plus Grade Pay 4200 in PB-2 (revised) with 8/5 years regular service respectively under C&AG, Defence A/Cs, P&T, Railways, A/Cs. Department.

- VI **JUNIOR ACCOUNTS OFFICER (04 posts) :-**Group 'B' (Non-Gazetted) in the scale of pay of Rs. 5500-175-9000/- (Revised PB-2, 9300-34800 plus Grade Pay Rs.4200/-) one each at Patna, Ahmedabad, Hyderabad & Jaipur Bench on transfer on deputation basis initially for a period of one year.

Eligibility Criteria:-

- (i) Officials under the Central Government holding analogous post or SAS Accountant, Junior Accounts Officer in the various Accounting organizations; OR
- (ii) Assistants with 5 years of service/Upper Division Clerks of Central Government with 10 years of service in the grade who have undergone Cash & Accounts Training in ISTM or equivalent or possess three years experience of Cash, Accounts and Budget works.

- VII **HINDI TRANSLATOR(01 post) :-** Group 'B' (Non-Gazetted) Post in the scale of pay of Rs. 5500-175-9000/- (Revised Pay Band-2, 9300-34800 Plus Grade Pay Rs.4600/-) at Principal Bench, New Delhi on transfer on deputation basis initially for a period of one year.

Eligibility Criteria:-

1. Persons holding analogous posts on regular basis in Central/State Govt./High Courts and Subordinate Court thereto and possessing qualification and experience as under (iii) below
- OR
2. Persons holding post in the scale of Rs.5500-9000(Pre-revised) with 5 years regular service in the grade in the Central/State Govt./High Courts and Subordinate Court thereto and possessing qualification and experience as under (iii) below
 3. Persons holding:
 - (a) Master's degree of a recognized University in Hindi/English with English/Hindi as a compulsory/elective subject or as medium of examination at Degree level, or Master's Degree of a recognized University in any subject other than Hindi/English with Hindi/English medium and English/Hindi as a compulsory/elective subject or as medium of

- examination at Degree Level. Or Master's Degree of a recognized University in any subject other than Hindi/English with Hindi and English as a compulsory/elective subjects or either of the two as medium of examination and the other as a compulsory/elective subject at Degree Level, and
- (b) Recognized Diploma/Certificate course in Translation from Hindi to English and Vice-versa or two years experience of translation work from Hindi to English and Vice-versa in Central/State Govt. offices, including Govt. of India Undertakings.

VIII LIBRARY & INFORMATION ASSISTANT (03 posts) :- Group 'B' (Non-Gazetted) Post in the scale of pay of Rs. 5500-175-9000/- (Revised Pay Band-2, 9300-34800 Plus Grade Pay Rs.4200/-) one each at Madras, Patna & Bombay Bench on transfer on deputation basis initially for a period of one year.

Eligibility Criteria:-

- (i) Persons holding analogous posts in any Central/State Govt./High Courts and Courts subordinate thereto or in lower posts with at least 5 years regular service in the scale of Rs.4500-7000 (Pre-revised) or equivalent and possessing qualification and experience as under :

Essential:

- (i) A Degree or equivalent from a recognized University or equivalent.
(ii) A Bachelor's Degree in Library and Information Science from a recognized University or equivalent.
(iii) 2 years experience in a responsible capacity in a library of standing.

- Desirable:** (iv) Master's Degree in Library & Information Science of recognized University or equivalent or Degree in Law.
(v) Experience of Documentation in a responsible capacity.

IX COURT MASTER/STENOGRAPHER GRADE 'C' (20 posts) :-

Group 'B' (Non-Gazetted) in the scale of pay of Rs.5500-175-9000 (Revised PB-2, 9300-34800 Plus Grade Pay of Rs.4600/-) at Allahabad, Ahmedabad, Bombay, Bangalore, Calcutta, Chandigarh, Guwahati, Jabalpur, Madras & Patna Bench on transfer on deputation basis initially for a period of one year.

Eligibility Criteria:-

1. Court Master/Stenographer Grade 'C' from amongst Central Government/State Governments/High Courts with at least two years regular service or persons holding equivalent posts with at least two years regular service in the grade of Rs.5500-175-9000 (pre-revised) or
2. Stenographer Grade 'D' or persons holding equivalent posts with at least five years regular service in the grade of Rs.4000-100-6000 (pre-revised) and possessing a speed of 100 w.p.m. in shorthand and 30 w.p.m. in typewriting in English.

X STENOGRAPHER GRADE 'D' (09 posts) :-

Group 'C' (Non-Gazetted) in the scale of pay of Rs.4000-100-6000 (Revised PB-1, 5200-20200 plus Grade Pay 2400/-) at Principal Bench, Bangalore, Bombay, Cuttack, & Hyderabad on transfer on deputation basis initially for a period of one year.

Eligibility Criteria:- Stenographer Grade 'D' from amongst Central Government/State Governments/High Courts with at least two years regular service or persons holding equivalent posts with at least two years regular service in the grade of Rs.4000-100-6000(pre-revised) with 80 w.p.m. in shorthand and 30 w.p.m. in typewriting in English.

Note:-

- I. The period of deputation in respect of above posts including the period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Govt. shall ordinarily not exceed three years. The maximum age limit for the appointment shall not exceed 56 years on the closing date of receipt of application.

Number of vacancies and place of posting are subject to change.

2. The applications in the given proforma (duly typed in double space) together with attested copies of CR dossiers for the last five years of the eligible officials who are willing to be considered for the said posts and could be spared immediately, may be forwarded to the Principal Registrar, Central Administrative Tribunal, Principal Bench, 61/35, Copernicus Marg, New Delhi-110001 within 45 days from the date of circular.
3. While forwarding the applications, certificate to the effect that the officials are clear from vigilance point of view and there is no disciplinary case pending/contemplated against him/her, may also be given at the bottom of the enclosed proforma.
4. The department while forwarding applications may please ensure that the officials who volunteer for the post shall not be allowed to withdraw their names later on.
5. Applications received after the expiry of last date or otherwise found incomplete for want of ACRs/Vigilance Clearance Certificate or without the seal of the office will not be entertained.
